Strategic objective 1 Activity stream 1.1.	To support the Government of RM in streamlining national ADV policies To advocate for better legal leverages for the protection of the rights of victims of DV
Activity 1.1.1.	To provide expert opinion in advancing legal framework • Expert opinion on the current situation in the field of DV prevention and combating, including Trust Line statistics and challenges in protecting effectively the rights of the victims of DV have been provided during a Round Table organized on September, 20th by Law Center for Women in Chisinau. The problems expressed by participants in regard to the implementation of the Law nr. 45 and
	recommendations in addressing such have been collected by "La Strada" to be analyzed within a specialized study (see Activity 1.2.1.). "La Strada" attorney present the lessons learned and some recommendation for improvement of legal mechanism in order to ensure the adequate protection of women suffering of DV. The recommendations was submitted to one representative of working group special created to elaborate amendments for national legislation related to DV. • The exchange of experience and good practices on assistance and protection measures towards victims of DV with service providers have been assured by "La Strada's" representative during a Round Table,
	organized on October 22 nd by the Law Center for Women. The participation of "La Strada" representative allowed enrich/gain knowledge useful for the future effective interventions in cases of DV in the country.

Activity 1.2.1.	To conduct study on the impact of Law 45 from beneficiary perspective
·	• The study is planned for 2013 but at the end of 2012, its concept and methodology has been designed. The main objective of the study is to collect and analyze information on <i>de facto</i> implementation into the practice of <i>de iuro</i> provisions of the Law nr. 45 aimed at protection and assistance of victims of DV. This qualitative study is supposed to be based on analysis of information offered directly by victims of DV who beneficiated, or refused due some reasons from offered assistance and protection measures, and by professionals in the field on the national, regional or community levels.
Activity 1.2.2.	To conduct analysis of DV dimension, profile, victims' needs and state response from the TL perspective • The Activity Report "Trust Line for Women 0 8008 8008" presents the activity results during November 2009-December 2011. During this period the Trust Line received 2978 calls. All collected calls offer the
	opportunity to perform a 2-year comparative analysis of the Trust Line operation from the perspective of DV actors' profile, specifics of domestic violence manifestation considering age and marital status of victims/defenders, needs and difficulties encountered by persons attempting to solve DV issue. The Report has been published in Romanian and English (200 copies) and distributed to main Moldovan
	 stakeholders and actors in the field, also being placed on "La Strada"s website. The Annual (internal) Report resulted from the activity of Trust line activity, have been prepared by operators of the phone service that allows to monitor the DV violence due to reflections on victims states
	of affairs addressed to Trust Line. In 2012, the Trust Line operators offered counseling to 467 victims of DV.

	• 7 national publications, 9 regional publications, 4 press agencies as well as 5 media portals have been monitored as to identify how the problem of DV is reflected in the printed media. A total number of 78 articles on DV issue have been identified in the printed national mass media sources.
Strategic Objective 3.	To contribute to the development of human capacities to effectively address cases of domestic violence
Activity stream 3.1.	To enhance skills and abilities of service providers to effectively respond to the needs of victims
Activity 3.1.1.	 To organize training workshop for the service providers on couple therapy On February 23-24, a workshop "Therapeutic intervention in counseling of the couple at risk - efficient interventions for the prevention of domestic violence" have been organized 24 representatives of NGOs that provide assistance to subjects of DV. The agenda of the workshop was designed to include training sessions combined with good practices exchange among participants. The participants learned in practice specific techniques applied in therapy of the couple at risk.
Activity 3.1.2.	On October 24-27, a workshop "Psychological assistance of sexually abused children" for those 21 practicing psychologists from NGOs, state social assistance departments, Crisis centers/shelters who earlier participated in organized training workshops on the similar topic, based on new professional needs identified. The participants sheared experience and challenges in provision of a complex psychological assistance to child victims of sexual abuse. The results of post-training questionnaires filled in by participants reflected an increased level of knowledge necessary for better identification, diagnostics and interviewing children victims of sexual abuse.
Activity stream 3.2.	To provide info support to practitioners on approaches to DV cases
Activity 3.2.2.	 To provide training and guidance to local practitioners on protecting rights of DV victims In September-October, under the invitation of IOM Moldova, the expert from "La Strada" participated as a trainer in series of trainings "Protection and assisting victims of trafficking and domestic violence in the National System of Reference" organized in Orhei, Cimislia, Criuleni, StefanVoda. A total number of 6 trainings for average number 120 participants-members of multidisciplinary teams (social workers, psychologists, police officers, doctors etc.) responsible for solving DV cases, have been delivered. "La Strada"s expert focused on judicial precedents, national and international legal framework, European Court cases etc.
Strategic objective 4.	To ensure availability and accessibility to specialized services for victims of DV
Activity stream 4.1.	To provide victims of DV with easy-to-access protection tools
Activity 4.1.1.	 Provision of psychological counseling and info/legal support via Trust-Line for women 3926 calls have been received and counseled since October 2009 till the end of 2012; 948 calls have been received and counseled in 2012 as related to 422 cases of DV; Among those 948 calls, 467 calls have been received from victims of DV, 157 from community members; 23 from professionals, 9 from defenders, and others; 513 of Trust Line beneficiaries enjoyed legal counseling, social mediation and protection; 58 cases have been registered that regard children suffering from various forms of violence and abuse being provided with counseling, social mediation and case monitoring;
	 16 beneficiaries have been assisted by lawyer/attorney and represented in the court, among these 7 got Protection Orders.
